As used in this subdivision, the term "personal information" means information relating to the performance or merit of individual employees. Ald. Tuomala seconded. Ald. Hallmark, Johnson, Tuomala and Wilson voted aye with 0 nays.

After coming out of closed session, the board announced that they accepted Karla's resignation and opened the position to the public. Ald. Johnson moved to table the consolidation of court to Pineville, MO. Ald. Hallmark seconded. Ald. Hallmark, Johnson, Tuomala, and Wilson voted aye with 0 nays.
